# 2001 River Keepers Activities

**FM River**: Grant from EPA. Other funded partners are Energy and Environmental Research Center at UND and Prairie Public. Tool to building a greater understanding of the Red River. Water quality monitoring every other week at three sites. Presentations, displays, and a webpage (www.fmriver.org) to communicate the health of the river. Conducted a teacher and a citizen workshop.

**Paint the Drain:** A storm drain pollution awarenes program, continues with volunteers involvement.

**Voyageur Canoes:** Five used canoes plus a trailer bought from youth camp in Canada. One rebuilt. Sponsored by Dick Hentges, Ron Saeger and Ed Janzen.

**Circle Bike Path:** Worked with FM COG and Fargo Park District on plan to complete the downtown riverfront circle bike path.

**Riverfront Development Committee:** A master plan for the Fargo side of the riverfront between Dike East and Oak Grove is being developed.

Main Avenue Bridge: Plans for an enhanced bridge that connects to the Red River are being developed.

**River Splash:** Fun For All Fishing Clinic, Fargo Park District's Lil'Fishermen's Derby, Scheels Kayak Demon-strations, Race the Red, free pontoon rides, and hands-on activities for youth held on June 9 at Dike East.

**National Trails Day**—Each reach of Phase 1 of the canoe trail was canoed on June 2 to promote the Red River as a canoe trail.

**Dams:** North Dam being retrofitted. Staff introduced a proposal to the the FM Metropolitan Council of Governments (COG)Water Task Force requesting a study of the Christine and Hickson Dams. Staff working with MN delegation to obtain money to retrofit South Dam. Received grant from MN DNR for dam safety signage at Christine and Hickson.

**Clean-ups:** Conducted several riv-erfront clean-up projects.

**Polar Party:** Organized ice fishing demonstration in February as a part of Moorhead Parks and Recreation's winter festival.

**Interpretive Signs:** Grant received from MN DNR for the nature trail at MB Johnson Park. Narrative and pictures developed.

Bank Stability: Project completed.

**SS Ruby,** pontoon tour boat: Sponsored by Houston Engineering, City of Fargo, City of Moorhead, FM Convention & Visitors Bureau and Fargo Park District. Limited Scope Masters license received by captains. Passed US Coast Guard inspection. Christened August 10. Operated weekends in September giving tours of downtown riverfront

**Beginning Birding Seminar:** Held April 19th at the Hjemkomst Center. 40 participants. Sponsored by: ND Game & Fish, F-M Audubon, Audubon Society—ND Chapter, Moorhead Parks and Recreation.

**The Red River Water Festival:** Held on November 15 for over 350 4th grade students in the Southeast Cass Water Resource District and the Buffalo-Red Watershed District. Sponsored by Project WET, EPA Region 8, Clay County Soil & Water Conservation District—Local Water. Plan.

Lions Conservancy Park: Grants re-ceived to install trail system and outdoor classroom. Several tours conducted.

**Grass Clippings:** With Moorhead Water Treatment Plant and the Clay County Water Planner developed an education campaign regarding the illegal dumping of grass clippings and other items into the River.

**Race the Red**: For the first time, two races held (7 mile competitive and 4 mile fun). 23 teams participated including one from Selkirk, Manitoba. Sponsored by Moorhead Amateur Sports Commission.

**Biological Monitoring Workgroup:** Set and retrieved artificial substrates at three sites being monitored chemically. Barnesville biology students counted and identified some of the macroinvertebrates.

**Red River of the North International Historic Canoe Trail:** Public information meetings held in Breckenridge, Abercrombie, Wolverton. Due to efforts by Project Breckenridge, Minnesota legislature appropriated \$100,000 to MN Department of Natural Resources (DNR) for inventory and mapping of the United States portion of the Red and signage on the first 120 miles. MN DNR contracted with River Keepers to develop master plan.
